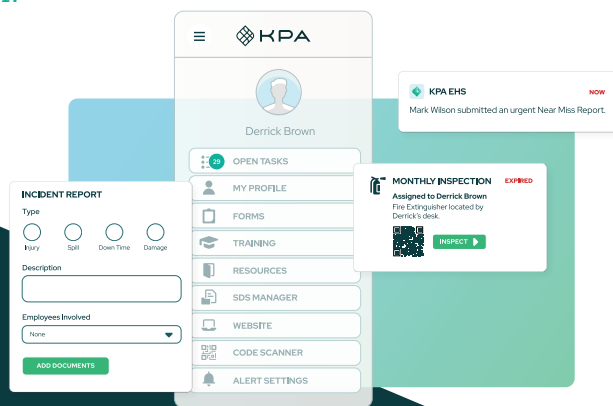
Incident Management

Toolbox Talks and Training
